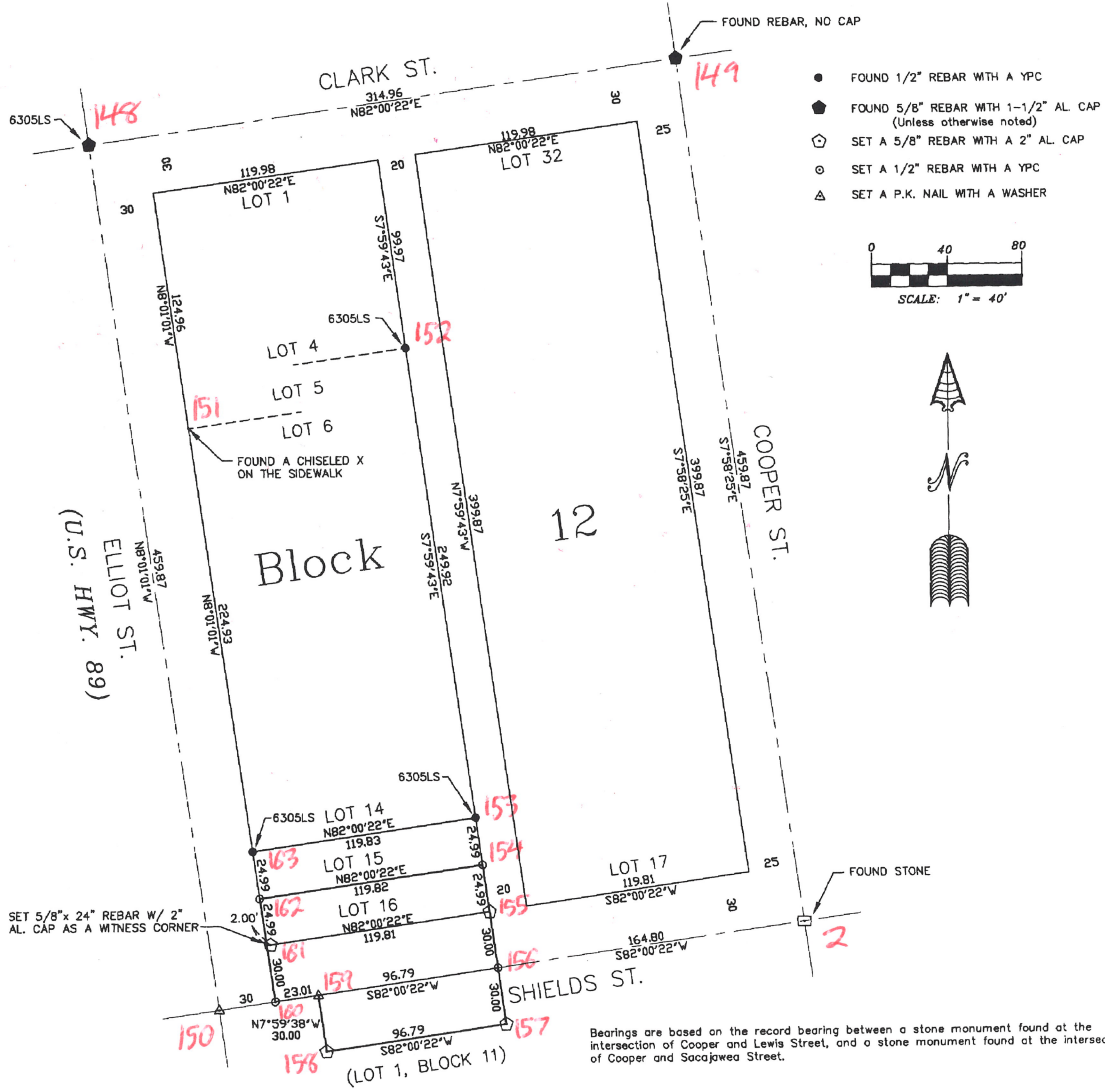


CERTIFICATE OF SURVEY No. 1630

A RESURVEY OF A PORTION OF BLOCK 12 OF WILSALL TOWNSITE AND THE ABANDONED PORTION OF SHIELDS STREET BETWEEN LOT 16 OF BLOCK 12 AND LOT 1 OF BLOCK 11.



Bearings are based on the record bearing between a stone monument found at the intersection of Cooper and Lewis Street, and a stone monument found at the intersection of Cooper and Sacojwea Street.

Purpose of Survey:

This survey was performed at the request of Dr. Rodney Longfellow to locate and monument the boundaries of his property as described in the deed recorded on page 402 of Roll 38 of Deeds.

Surveyors Notes:

- The portion of Shields Street between Cooper and Elliot Streets was abandoned by order of the Park County Board of Commissioners dated August 12, 1981. That order is included in File No. 41 of the records of road and street abandonments.
- The deed recorded on page 402 of Roll 38 purports to transfer all of that portion of Shields between Lot 1 of Block 11 and Lot 16 of Block 12 to Dr. & Mrs. Longfellow. Fee Title to the westerly 30 ft. of Lot 1 of Block 11 had previously been acquired by the Montana Department of Transportation in 1971. With the 1981 abandonment, the MDT would take title to the centerline of the abandoned portion of Shields Street adjacent to the property it had acquired in 1971.
