

INSTRUCTIONS

1. Original and, equal record used to evaluate the corner position.
2. Description of stone found, note discrepancies in the record, state method of establishment or obliterated corners.
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch of corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Land Surveyor registered in the State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

SET A GRANITE STONE, 12X10X6 INS., 8 INS. IN THE GROUND, FOR QUARTER CORNER, MARKED 1/4 ON WEST FACE; FROM WHICH

- A PINE, 6 INS. DIAM., BEARS N23°E, 72 LKS. DIST., MARKED 1/4S18BT.
- A PINE, 6 INS. DIAM., BEARS N28°W, 43 LKS. DIST., MARKED 1/4S13BT.

2. 1997 MIKE D. WELDON

FOUND A WELL SET GRANITE STONE, 8X6X5 INS., ABOVE GROUND MARKED 1/4 ON WEST FACE. A MOUND OF STONE ALONG SOUTH SIDE OF CORNER STONE. FROM WHICH

- A PINE SNAG, 6 INS. DIAM., 6 FT. HIGH, BEARS N32°W, 24.0 FT. DIST., MARKED "1/4S13BT".
- A PINE SNAG, 8 INS. DIAM., 5 FT. HIGH, BEARS N25°E, 46.4 FT. DIST., MARKED "1/4S18BT".

3. 1997 MIKE D. WELDON

1 MARK 2 NEW BEARING TREES.

- A LODGE POLE PINE 12 INS. DIAM., BEARS S53°E, 30.8 FT. DIST., SCRIBED "1/4S18BT".
- A LODGE POLE PINE 13 INS. DIAM., BEARS S60°W, 14.5 FT. DIST., SCRIBED "1/4S13BT".

BEARING TREE SIGNS WERE AFFIXED TO THE FRONT AND LAND SURVEY MONUMENT SIGNS TO THE BACK OF THE BEARING TREES. REGISTERED LAND SURVEYOR, "RLS 7692-S" WASHERS WERE AFFIXED TO THE SIDE CENTER OF THE BEARING TREES AT THE BASE.

CORNER FALLS JUST EAST OF A NORTH-SOUTH FENCE, AND AREA SOUTHWEST OF CORNER WAS RECENTLY LOGGED.

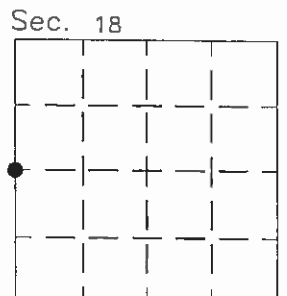
