

# PLSS CORNER RECORD

Corner: W1/16 S30/S31 T. 16 N., R. 12 W. P.M.M. Powell County

1984 Remonumentation by Stanley Skousen as follows:

At the calculated position, set a standard USDA alum. drivable pipe with 3 1/4 in. alum. cap 6 ins. above ground marked as shown.

Established two bearing trees described as follows:

A lodgepole pine, 16 ins. diam., bears S. 54°30' W., 45.2 ft. dist., scribed (WC 1/16 S30 BT)

A lodgepole pine, 15 ins. diam., bears N. 11° W., 42.1 ft. dist., scribed (WC 1/16 S30 BT)

Description of Corner Evidence Found:

The alum. cap monument was recovered in good shape, the NW BT is dead standing and the SW BT is dead and down. During the course of my survey I discover a significant positional blunder error that I have fixed, the survey information will be filed on a Certificate of Survey.

Description Of Monument And Accessories Established:

The 1984 1/16 corner monument was moved to the correct position according to my survey, set 24 inches in the ground, with alum. Forest Service cap now marked as shown, and in a collar of stone 2 ft. diam., from which

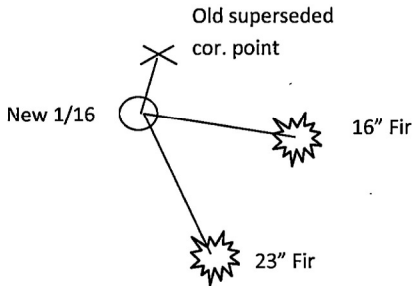
A fir, 16 ins. diam., bears S. 80 1/2° E., 54.5 ft. dist., marked X BT

A fir, 23 ins. diam., bears S. 22 1/2° E., 67.5 ft. dist., marked W1/16S30BT

From this new corrected 1/16 cor. point, the old superseded corner point bears N. 15°15'27" E., 7.52 ft. dist.,

The BT's were signed and the blazes were painted red, I measure the distances to a nail in the side at center. Corner is located on flat mostly open ground approx. 20 ft. W. of a dirt road.
