THE RYAN DAM DEVELOPMENT WATER RIGHTS WERE INCLUDED IN THE REPORT OF THE SPECIAL MASTER SUBMITTED IN THE MONTANA POWER CO. VS BROADWATER-MISSOURI WATER USERS ASSOC. CASE FILED WITH THE UNITED STATES DISTRICT COURT OF MONTANA, HELENA. THE SPECIAL MASTER'S REPORT WAS ADOPTED IN THE DISTRICT COURT DECISION REPORTED AS MONTANA POWER CO. VS BROADWATER-MISSOURI WATER USERS ASSOC., 50 F. SUPP. 4 (1942). EVEN THOUGH THE DISTRICT COURT DECISION WAS REVERSED ON JURISDICTIONAL GROUNDS IN BROADWATER-MISSOURI WATER USERS ASSOC. VS MONTANA POWER CO., 139 F.2D 998 (1944), THE SPECIAL MASTER'S REPORT MAY BE A FACTUAL DESCRIPTION OF THE WATER RIGHTS AT RYAN DAM. THE SPECIAL MASTER FOUND THE MONTANA POWER COMPANY HAD: "1ST. A WATER RIGHT OF THE AMOUNT OF WATER NECESSARY TO OPERATE THE POWER PLANT UP TO THE MAXIMUM OF 5900 SECOND FEET AS OF AUGUST 31, 1915, WHICH IS THE DATE THAT THIS DEVELOPMENT WAS PUT INTO OPERATION. 2ND. A WATER RIGHT AS OF AUGUST 31, 1915, IN THE AMOUNT OF 1407 CUBIC FEET PER SECOND BUT NOT IN EXCESS IN VOLUME OF THE NUMBER OF SECOND FOOT DAYS NECESSARY TO
