THE VOLUME WAS AMENDED BY THE CLAIMANT ON 11/20/2009.

THE MORONY DAM DEVELOPMENT WATER RIGHTS WERE INCLUDED IN THE REPORT OF THE SPECIAL MASTER SUBMITTED IN THE MONTANA POWER CO. VS BROADWATER-MISSOURI WATER USERS ASSOC. CASE FILED WITH THE UNITED STATES DISTRICT COURT OF MONTANA, HELENA. THE SPECIAL MASTER'S REPORT WAS ADOPTED IN THE DISTRICT COURT DECISION REPORTED AS MONTANA POWER CO. VS BROADWATER-MISSOURI WATER USERS ASSOC., 50 F. SUPP. 4 (1942). EVEN THOUGH THE DISTRICT COURT DECISION WAS REVERSED ON JURISDICTIONAL GROUNDS IN BROADWATER-MISSOURI WATER USERS ASSOC. VS MONTANA POWER CO., 139 F.2D 998 (1944), THE SPECIAL MASTER'S REPORT MAY BE A FACTUAL DESCRIPTION OF THE WATER RIGHTS AT MORONY DAM. THE SPECIAL MASTER FOUND THE MONTANA POWER COMPANY HAD: "1ST. A WATER RIGHT OF THE AMOUNT NECESSARY TO OPERATE THE POWER PLANT UP TO A MAXIMUM OF 7150 SECOND FEET AS OF DECEMBER 20, 1928, WHICH IS THE DATE OF THE NOTICE OF APPROPRIATION. 2ND. A WATER RIGHT AS OF DECEMBER 20, 1928, IN THE AMOUNT OF 3981 CUBIC FEET PER SECOND BUT NOT IN EXCESS IN VOLUME OF THE NUMBER OF SECOND FOOT DAYS NECESSARY TO FILL THE MORONY RESERVOIR AT ANY GIVEN TIME." IN REFERENCE TO THE FLOW RATE REPRESENTED IN THE MASTER'S REPORT FOR MORONY DAM, THE FOLLOWING STATEMENT WAS SUBMITTED BY CLAIMANT AT TIME OF FILING WITH STATEMENT OF CLAIM. "REVIEW AND ANALYSIS OF THE FIFTY YEARS OF WATER USE RECORDS MAINTAINED SINCE THE MORONY PLANT BEGAN OPERATING INDICATES THIS AWARD UNDERSTATES THE PLANT'S ACTUAL WATER USE. THIS REVIEW CONCLUSIVELY ESTABLISHES THE FACT THAT A FLOW OF 8280 CFS IS USED AT MORONY. THE ATTACHED CLAIM FORMS AND SUPPORTING EXHIBITS DETAIL
