THE OWNERS WILL SHARE DITCH LOSSES EQUALLY FROM THE DIVERSION TO WHERE THE HOOPER DITCH DIVERTS IN THE NESWSE SECTION 20, T14N, R8W.

EITHER OWNER MAY DIVERT UP TO 15.93 CFS AS LONG AS THE SUM OF DIVERSIONS MADE UNDER THIS CLAIM DOES NOT EXCEED 15.93 CFS.

SHOULD CONFLICT ARISE IN THE OPERATION OF THIS RIGHT, THE DIVERTED FLOW SHALL BE SHARED PROPORTIONATELY BASED UPON THE ACRES IRRIGATED UNDER THIS CLAIM. BALDY MOUNTAIN RANCH WOULD RECEIVE 44% OF DIVERTED FLOWS AND GEHRING RANCH CORPORATION WOULD RECEIVE 56% OF DIVERTED FLOWS.

STARTING IN 2008, PERIOD OF DIVERSION WAS ADDED TO MOST CLAIM ABSTRACTS, INCLUDING THIS ONE.
