EACH RIGHT IS LIMITED TO THE FLOW RATE AND PLACE OF USE OF THAT INDIVIDUAL RIGHT. THE SUM TOTAL VOLUME OF THESE WATER RIGHTS SHALL NOT EXCEED THE AMOUNT PUT TO HISTORICAL AND BENEFICIAL USE.

THIS RIGHT IS SUBJECT TO THE AUTHORITY OF THE DEPARTMENT TO REVOKE THE RIGHT IN ACCORDANCE WITH 85-2-314 OR 85-2-402(9), MCA, AND TO ENTER ONTO THE PREMISES FOR INVESTIGATIVE PURPOSES IN ACCORDANCE WITH 85-2-115, MCA.

THE AMOUNT OF WATER TO BE USED INTERMITTENTLY FOR FISHERY DEPENDS ON HYDROLOGIC CONDITIONS IN LAZYMAN CREEK. THE AMOUNT OF WATER USED FOR IRRIGATION SHALL BE REDUCED WHEN NECESSARY TO MAINTAIN 1.0 CFS OF STREAMFLOW BELOW THE POINT OF DIVERSION. THE MAXIMUM AMOUNT OF WATER FOR FISHERY USE WOULD BE 1.0 CFS UP TO 253 ACRE-FEET PER YEAR. THE MAXIMUM AMOUNT OF WATER USED FOR BOTH FISHERY AND IRRIGATION WOULD NOT EXCEED 3.0 CFS UP TO 720 ACRE-FEET PER YEAR.

THIS LEASE IS FOR 10 YEARS AND WILL EXPIRE IN 2021.

THIS WATER RIGHT IS ASSOCIATED WITH 41C 100953-00, A STATEMENT OF CLAIM FOR RUBY RIVER WATER. THIS CHANGE AUTHORIZATION ON 41C 100955-00 IS CONDITIONED SO THAT IF RUBY RIVER WATER IS USED UNDER 41C 100953-00 TO IRRIGATE THE OVERLAPPING ACREAGE, THE APPLICANT WILL SUBMIT A REPORT TO DNRC DETAILING HOW USE UNDER THIS CHANGE AUTHORIZATION WAS CURTAILED. THE CONSUMPTIVE USE ON THE 33.6 ACRES IS NOT TO EXCEED 29.1 AF BETWEEN THE TWO WATER RIGHTS.

WHEN FLOW IN LAZYMAN CREEK DROPS BELOW 4 CFS, THE 3 CFS DIVERSION FOR IRRIGATION WILL BE DECREASED TO ALWAYS MAINTAIN 1 CFS OF INSTREAM FLOW IN LAZYMAN CREEK.

MT DFWP OR ITS DESIGNEE SHALL MEASURE THE PROTECTED REACH OF LAZYMAN CREEK IN MADISON COUNTY IN ACCORDANCE WITH THE SUBMITTED STREAMFLOW MEASURING PLAN USING DEPARTMENT APPROVED MEASURING DEVICES. MEASUREMENTS WILL BE TAKEN MONTHLY DURING THE PERIOD OF USE, WITH INCREASING FREQUENCY AS FLOWS NEAR THE TRIGGER FLOW OF 4 CFS. ANY MEASUREMENT RECORDED ON LAZYMAN CREEK BELOW 4.0 CFS WILL BE COMMUNICATED TO THE WATER RIGHT OWNER AND TRIGGER THE EXECUTION OF THE LEASE AGREEMENT. MEASUREMENT RECORDS SHALL BE MADE AVAILABLE TO THE DEPARTMENT UPON REQUEST.

THIS CHANGE AUTHORIZATION IS SUBJECT TO THE PERMANENT REMOVAL AND NON-IRRIGATION OF 11.4 ACRES FROM IRRIGATION AT A LOCATION IN SECTION 33 AND 34 IN T9S R3W IN MADISON COUNTY (SEE FILE FOR MAP OF SPECIFIC ACREAGE).
