A RECORD OF ANY SYSTEM CHANGES ALONG WITH WRITTEN RECORDS OF THE DIVERSION SCHEDULE SHALL ALSO BE MAINTAINED. ON A FORM PROVIDED BY THE DEPARTMENT, THE APPROPRIATOR SHALL OBTAIN YEARLY ELECTRICAL CONSUMPTION RECORDS AND FROM THOSE RECORDS CALCULATE THE VOLUME OF WATER DIVERTED.
