THE PRIORITY DATE MAY BE QUESTIONABLE. THE RAVALLI COUNTY WATER RESOURCES SURVEY (1958) IDENTIFIES THE PRIORITY DATE AS AUGUST 15, 1941.

WATER IS NOT DIVERTED FROM THE SOURCE CLAIMED. A HISTORICAL APPROPRIATION FROM THE CLAIMED SOURCE CANNOT BE CONFIRMED.
