DURING THE COMPLETION PERIOD, THE APPROPRIATOR MAY CONTINUE TO USE WATER ASSOCIATED WITH STATEMENT OF CLAIM NO. 76M-110493-00 FOR IRRIGATION ON ACRES NOT RETIRED PROVIDED THAT PROPORTIONATE AMOUNTS OF THE APPROPRIATION RIGHT ARE RETIRED AS THE BENEFICIAL USE FOR MITIGATION UNDER THIS CHANGE AUTHORIZATION IS PERFECTED. IF THE FULL AMOUNT OF WATER AUTHORIZED FOR CHANGE TO MITIGATION IS NOT SOLD OR LEASED AS MITIGATION PRIOR TO THE 20-YEAR COMPLETION DATE, THE WATER RIGHT RETAINS THE BENEFICIAL USE IN PROPORTIONATE AMOUNTS NOT PERFECTED FOR MITIGATION AND AS AUTHORIZED PRIOR TO THIS CHANGE AUTHORIZATION. THE APPROPRIATOR SHALL NOTIFY THE DEPARTMENT WITHIN 30 DAYS EACH TIME A PORTION OF THE CHANGE IS COMPLETED ON A FORM PROVIDED BY THE DEPARTMENT.

THE PLACE OF USE FOR MARKETING FOR MITIGATION IS THE CLARK FORK RIVER BETWEEN THE HEADGATE IN THE NENESE OF SECTION 22 T13N, R20W, MISSOULA COUNTY TO NOXON RAPIDS POWERHOUSE LOCATED IN THE S2S2 OF SECTION 33, T26N, R32W, SANDERS COUNTY.

THE WATER RIGHTS FOLLOWING THIS STATEMENT ARE SUPPLEMENTAL WHICH MEANS THE RIGHTS HAVE OVERLAPPING PLACES OF USE. THE RIGHTS CAN BE COMBINED TO IRRIGATE ONLY OVERLAPPING PARCELS. EACH RIGHT IS LIMITED TO THE FLOW RATE AND PLACE OF USE OF THAT INDIVIDUAL RIGHT. THE SUM TOTAL VOLUME OF THESE WATER RIGHTS SHALL NOT EXCEED THE AMOUNT PUT TO HISTORICAL AND BENEFICIAL USE W110493-00, W110492-00.

THE APPROPRIATOR SHALL INSTALL A STAFF GAUGE AT THE HEADGATE TO ALLOW FOR ADJUSTMENTS TO THE FLOW RATE AS WATER IS SOLD/LEASED FOR THE PURPOSE OF MITIGATION. PHYSICAL FLOW MEASUREMENTS WILL BE TAKEN AT THE HEADGATE AND A STAGE RATING CURVE WILL BE DEVELOPED TO ENSURE THAT WATER SOLD/LEASED FOR THE PURPOSE OF MITIGATION REMAINS IN THE CLARK FORK RIVER THROUGHOUT THE PERIOD OF DIVERSION. THE APPROPRIATOR SHALL MAINTAIN ALL MEASURING DEVICES SO THAT THEY ALWAYS OPERATE PROPERLY AND MEASURE FLOW RATES AND VOLUMES ACCURATELY. ON A FORM PROVIDED BY THE DEPARTMENT, THE APPROPRIATOR SHALL KEEP A MONTHLY WRITTEN RECORD OF FLOW RATES AND VOLUMES OF WATER DELIVERED THROUGH THE HEADGATE. RECORDS SHALL BE SUBMITTED TO THE DEPARTMENT BY NOVEMBER 30TH OF EACH YEAR AND UPON REQUEST AT OTHER TIMES DURING THE YEAR. THE APPROPRIATOR SHALL ALSO SUBMIT MAPS TO THE DEPARTMENT PRIOR TO EACH IRRIGATION SEASON, INDICATING ACRES BEING DRIED UP FOR THE PURPOSE OF MITIGATION. FAILURE TO SUBMIT MAPS AND REPORTS MAY BE CAUSE FOR REVOCATION OF THIS CHANGE.
