THE APPROPRIATOR SHALL KEEP A WRITTEN RECORD OF THE FLOW RATE AND VOLUME OF ALL WATERS DIVERTED INCLUDING THE PERIOD OF TIME AND SHALL SUBMIT SAID RECORDS TO THE DEPARTMENT UPON REQUEST.
