THE COMBINED CLAIMED FLOW RATE FOR THIS GROUP OF SUPPLEMENTAL RIGHTS IS 6710 CFS WHICH APPEARS TO EXCEED THE CAPACITY OF THE B CANAL. THE PONDERA COUNTY WATER RESOURCES SURVEY (1964) INDICATES THE DITCH CAPACITY TO BE 700 CFS.

THIS CLAIM DOES NOT APPEAR TO REFLECT THE WATER RIGHT AS IT WAS BEFORE JULY 1, 1973. SERVICE AREA MAP RECEIVED NOVEMBER 23, 2005 APPEARS TO INDICATE A POST-JUNE 30, 1973 EXPANSION OF THE NUMBER OF ACRES WITHIN THE SERVICE AREA BOUNDARY.

THE TOTAL ACREAGE OF THE SERVICE AREA IS IN QUESTION. ON FEBRUARY 5, 2007, THE SERVICE AREA WAS AMENDED TO INCLUDE FULL 640 ACRE SECTIONS. THIS RESULTED IN AN INCREASE OF 558 ACRES IN THE SERVICE AREA, 558 ACRES MORE THAN THE AREA CAN CONTAIN.

ACCORDING TO THE NATIONAL INVENTORY OF DAMS, SWIFT RESERVOIR WAS CONSTRUCTED IN APPROXIMATELY 1909, THEN FAILED IN 1964 AND WAS RECONSTRUCTED IN 1967 WHICH DOES NOT CORRESPOND TO THE CLAIMED PRIORITY DATE. THIS MAY INDICATE AN EXPANSION OF THE WATER RIGHT.

ACCORDING TO THE HISTORY OF THE VALIER PROJECT (APRIL 27, 1920), LAKE FRANCIS WAS CONSTRUCTED IN 1902, WHICH DOES NOT CORRESPOND TO THE CLAIMED PRIORITY DATE. THIS MAY INDICATE AN EXPANSION OF THE WATER RIGHT.

THE COMBINED CLAIMED FLOW RATE FOR THIS GROUP OF SUPPLEMENTAL RIGHTS IS 78 GPM PER ACRE. THE FLOW RATE GUIDELINE FOR INDIVIDUAL CLAIMS IS 17 GPM PER ACRE.
