A RESOLUTION ANNEXING PROPERTY INTO THE

1. The request for annexation (attached as Exhibit A) contains the signatures of more than 50 percent of the owners of the property to be annexed.
2. The boundaries of the City of Shelby are to be extended to include the private real property (attached as Exhibit B), described as follows:
Parcel of property situated in Section 22, Township 32 North, Range 2 West, C.O.S 2016-3, P.M.M., Toole County, Montana, containing 3.79 acres (6 City Shop Rd, Shelby MT)
3. These tracts shall be zoned Rural Residential and included in Ward 1 of the City of Shelby for voting purposes.

FURTHER, this resolution shall be incorporated into the minutes of the city council of the City of Shelby.

That the parcel of real property hereinabove stated, owned by Dee Harris is hereby annexed into the municipal limits of the city of Shelby.

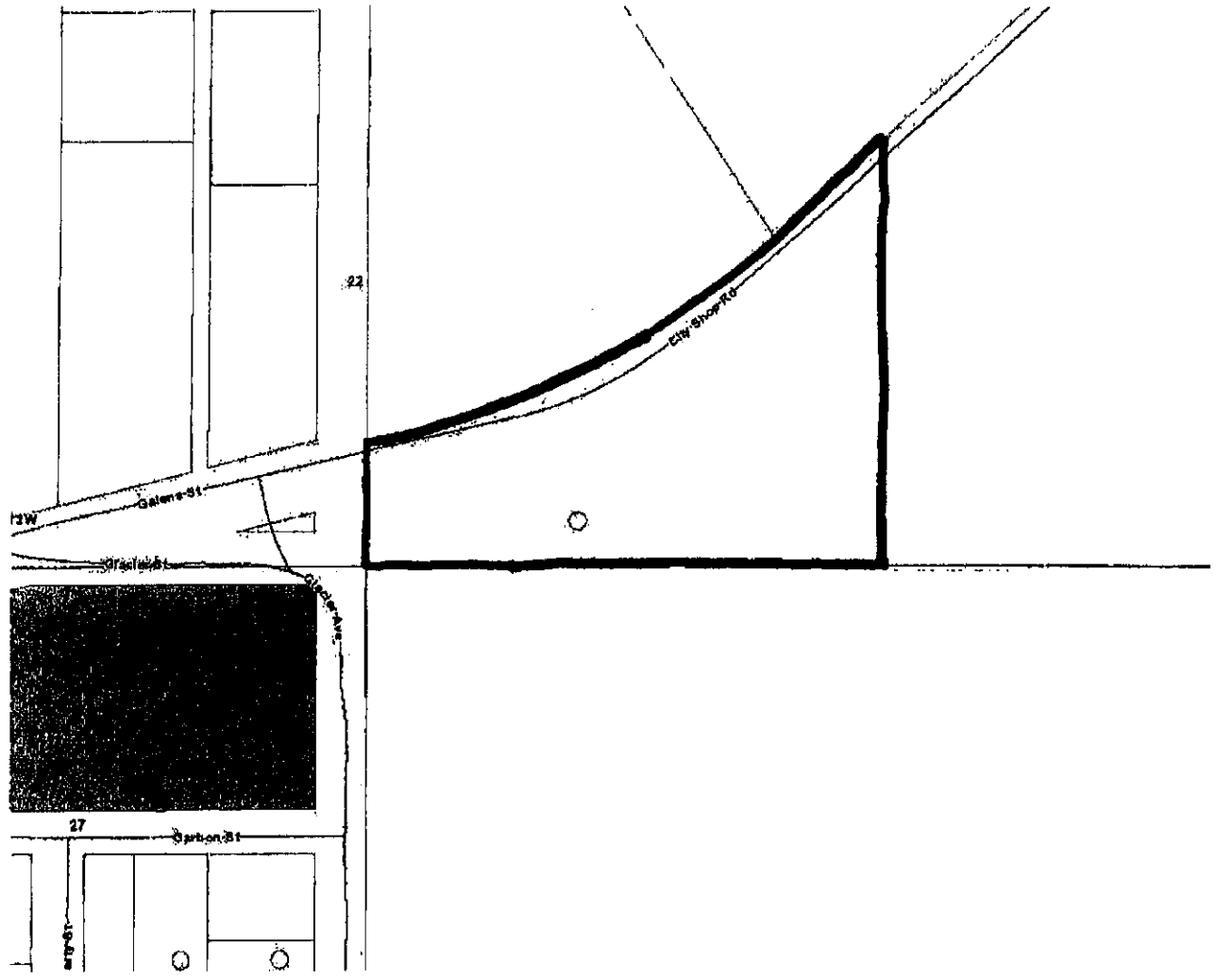

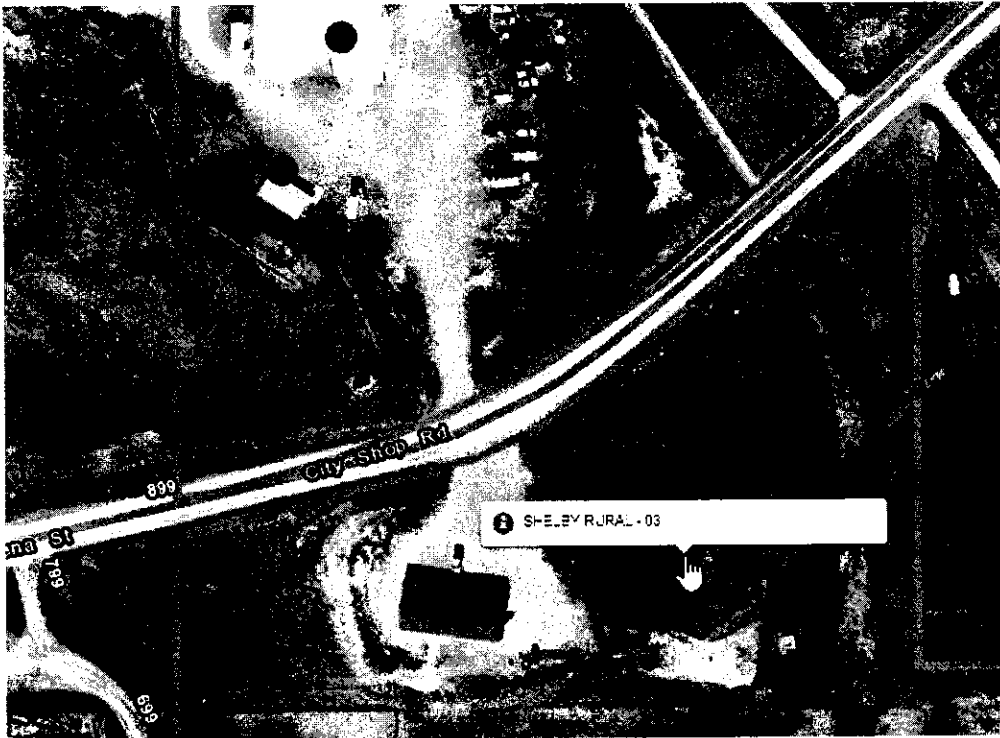
