

INSTRUCTIONS

1. Original and/or subsequent record used to evaluate the corner position.
2. Description of evidence found, note discrepancies in the record, state method of establishing lost or obliterated corners.
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch of corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Land Surveyor registered in the State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

ORIGINAL RECORD: (1885 G.L.O.) Survey by George Scheetz.

SUBSEQUENT RECORD: (1939 G.L.O.) Proportional point for the 1/4 sec. cor., Set an iron post, 3 ft. long, 1 ins. diam., 28 ins. in the ground, for 1/4 cor. with brass cap marked as shown, from which a cottonwood, 18 ins. diam., bears S. 61°0' E., 37 lks. dist., marked 1/4 S 8 BT. A cottonwood, 12 ins. diam., bears N. 65°0' W., 54 lks. dist., marked 1/4 S 5 BT.

SUBSEQUENT RECORD: None found

EVIDENCE FOUND: Found 2 1/2" Brass cap, 0.4' above ground and bent 0.22' to east. Replied the stones. Point out in grassy field with numerous scattered cottonwoods. There is a farmer "T" post, 4.9' to the west. Road is ±600' to the NW.

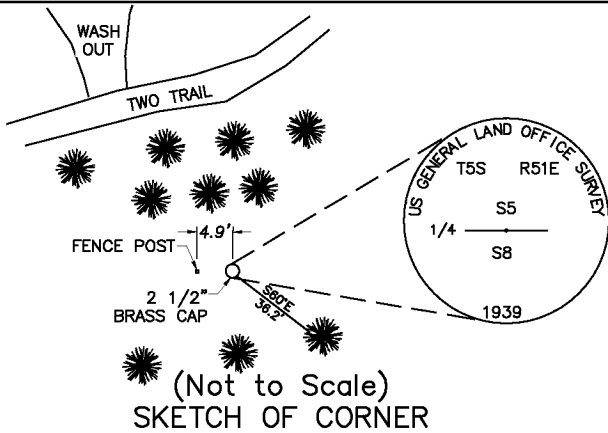
PERPETUATION: Established a latitude and longitude for search purposes.
