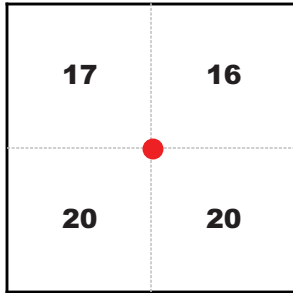

 STAKE WITH THE ORIGINAL CORNER LYING ALONG SIDE OF

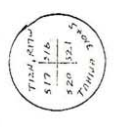
I CUT THE EXISTING 2" PIPE OFF WITH

 BEARS 1.65" W, 1.52" FEET, BLAZE A PIPE WHICH BEARS 344" W,
 52.0" FEET, BEARS A COTTON WOOD WHICH BEARS 328" E, 27.9" FEET.
 I PLACE A MARBLE STERILE MONUMENT TWO ON EACH TREE.
