A 14 in. pine bears S. 53° E., 69 lks. (45.54 ft.) marked T. 17 N., R. 27 W., S. 13 BT.

A 14 in. pine bears S. 62° W., 29 lks. (19.14 ft.) marked T. 17 N., R. 27 W., S. 14 BT.

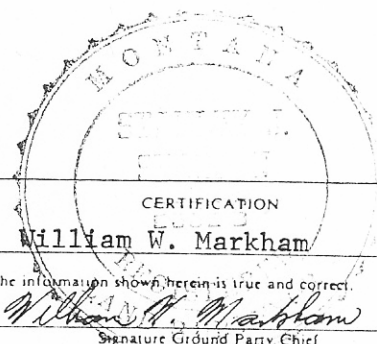
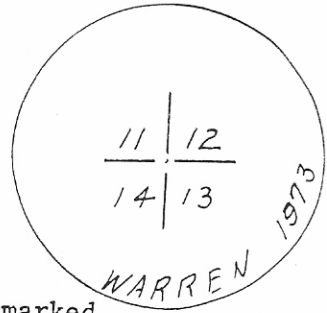
A 14 in. pine bears N. 60° W., 9 lks. (5.94 ft.) marked T. 17 N., R. 27 W., S. 11 BT.

Established 1 RM tree:

Posted BT and land survey monument signs.
