

CERTIFIED LAND CORNER RECORDATION

DESCRIPTION OF CORNER EVIDENCE FOUND, AND ORIGINAL RECORD (IF KNOWN)

From the corner to secs., 15, 16, 21 and 22, which is a slate stone, 14x8x5 ins., 10 ins., in the ground marked with 3 notches on S. and E. edges, from which

- A pine, 5 ins. diam., bears N.80°E., 15 lks. dist., marked T 24 N R 19 W S 15 B T
- A pine, 5 ins. diam., bears S.64°E., 7 lks. dist., marked T 24 N R 19 W S 22 B T
- A pine, 20 ins. diam., bears S.26°W., 69 lks. dist., marked T 24 N R 19 W S 21 B T
- A fir, 7 ins. diam., bears N.16°W., 12 lks. dist., marked T 24 N R 19 W S 16 B T

DESCRIPTION OF MONUMENT AND ACCESSORIES ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

The original corner is gone. A pipe 1 1/2" diameter with a pipe cap occupies the present corner location. I cannot determine who set this corner, probably Mr. Steere, a local surveyor who has done some surveys in section 16 to the North. Date of work: 2-27-75

- The north east bearing tree is gone.
- The south east bearing tree is gone
- The south west bearing tree is fire scarred.
- The west bearing tree is tagged.

I could not verify any scribing on any of the trees. However, the S.W. and N.W. trees do occupy the original BT pattern.

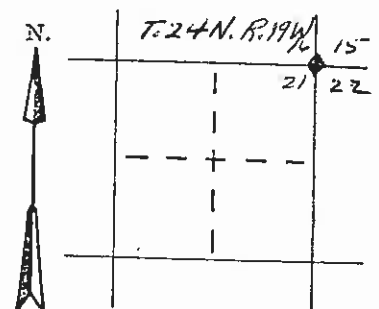
