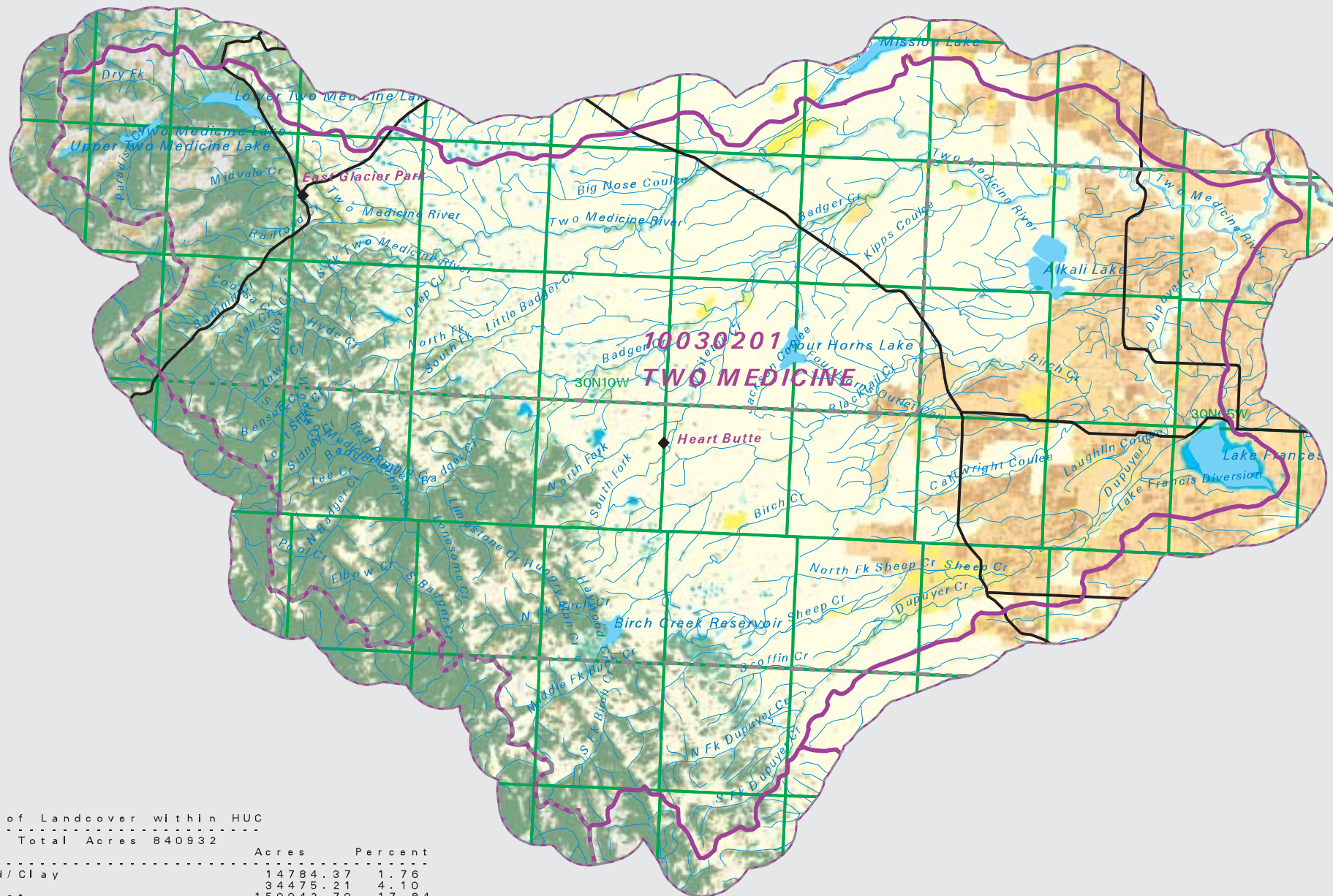


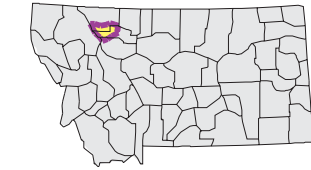

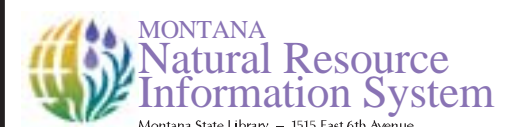


Mapscale 1: 420000, Scale in miles:
