WATER MEASUREMENT-WATER USE MEASURING DEVICE

THE APPROPRIATOR SHALL INSTALL A FLOW MEASURING DEVICE APPROVED BY THE REGIONAL MANAGER AT A POINT DESIGNATED BY THE REGIONAL OFFICE TO ALLOW THE FLOW RATE AND VOLUME OF WATER DIVERTED TO BE RECORDED. WATER MUST NOT BE DIVERTED UNTIL THE REQUIRED MEASURING DEVICE IS IN PLACE AND OPERATING. ON A FORM PROVIDED BY THE DEPARTMENT, THE APPROPRIATOR SHALL KEEP A WRITTEN MONTHLY RECORD OF THE FLOW RATE AND VOLUME OF ALL WATER DIVERTED INCLUDING THE PERIOD OF TIME, AND SHALL SUBMIT THE RECORDS BY NOVEMBER 30 OF EACH YEAR. THE REGIONAL MANAGER MAY ALSO REQUEST MEASUREMENT RECORDS AT OTHER TIMES DURING THE YEAR. FAILURE TO SUBMIT REPORTS MAY BE CAUSE FOR REVOCATION OR MODIFICATION OF A PERMIT OR CHANGE. THE RECORDS MUST BE SENT TO THE WATER RESOURCES REGIONAL OFFICE AT THE ADDRESS LISTED BELOW.
