NO FLOW RATE HAS BEEN DECREED BECAUSE THIS RIGHT USES A SERIES OF ONSTREAM RESERVOIRS TO ACT AS CHECK STRUCTURES TO DISTRIBUTE WATER THROUGH A WATER SPREADING SYSTEM TO THE PLACE OF USE. AFTER A RESERVOIR FILLS TO CAPACITY, WATER SPREADS OUT THROUGH DITCHES TO ADJACENT FIELDS. THE STORED WATER IN AN UPSTREAM RESERVOIR CAN ALSO BE RELEASED TO FILL THE NEXT DOWNSTREAM RESERVOIR TO PERFORM THE SAME WATER SPREADING FUNCTION.

THE VOLUME OF 4,548 ACRE FEET IS COMPOSED OF THE 1,900 AF COMBINED CAPACITY OF 6 RESERVOIRS (EACH FILLED ONCE A SEASON) AND A COMBINED WATER SPREADING IRRIGATION VOLUME OF 2,648 AF BASED ON 2 AF PER IRRIGATED ACRE.
