THIS RIGHT WAS ORIGINALLY DECREED TO THE W2NE, N2SE, N2S2SE, SEC 11, THE W2SW SEC 12, AND THE NWNW SEC 13 ALL IN TWP 10N RGE 20W, RAVALLI COUNTY.
