OSIP Contracting

- Out of 88 Counties, 70 have participated in the OSIP Buy-up Program
 - Most of these counties have participated over multiple times/years; several have signed multiple projects over the life of the state contract
 - For every \$1 the state of Ohio has contributed to the program, approximately \$8 has been contributed by Ohio's Local Governments
